MOWING OF CUL-DE-SACS & PUMP STATIONS

THE TOWN OF HENRIETTA IS REQUESTING PRICE PROPOSALS FOR MOWING THE CUL-DE-SACS (OR CIRCLES) AND PUMP STATIONS.

- THE CIRCLES ARE TO BE MOWED ON AN AS NEEDED BASIS. IN THE SPRING TIME CUTTING IS USUALLY DONE EVERY WEEK. IN MID SUMMER WE MAY ONLY NEED TO BE CUT EVERY OTHER WEEK OR NOT AT ALL DEPENDING ON THE WEATHER TO BE DETERMINED BY TOWN.
- CLIPPINGS ARE TO BE KEPT OFF OF ROAD SURFACES AND ANY LARGE CLUMPS ARE TO BE DISPERSED. STRING TRIMMING EDGES OF AMENITIES AND AROUND TREES IS REQUIRED EACH TIME TO MAINTAIN A NEAT APPEARANCE.
- ALL CIRCLES AND PUMP STATIONS ARE LISTED AS ONE CONTRACT.
- ADDITIONAL CIRCLES MAY BE ADDED DURING THE CONTRACT PERIOD, INCLUDE A PRICE PER CIRCLE IN THE EVENT OF ADDED ONES.
- THIS CONTRACT SHALL BE FOR A THREE (3) YEAR PERIOD STARTING APRIL 2018 AND ENDING OCTOBER 2020.
- INSURANCE REQUIREMENTS AS DESCRIBED IN THE INVITATION TO BID. ITEM #6
- ANY AND ALL DAMAGE CAUSED BY THE CONTRACTOR TO PUBLIC OR PRIVATE PROPERTY WILL BE CORRECTED BY THE CONTRACTOR AT THEIR EXPENSE

4.) The attention of Bidders is called to the requirements concerning the conditions of employment to be observed and minimum wage rates to be paid under the Contract. **Bidders must comply with New York State Prevailing Wage Rates.**

5.) **Statement of Non-Collusion** - Bidders are required to execute a Non-Collusion Bidding Certificate pursuant to Section 103-d of the General Municipal Law of the State of New York.

6.) **Insurance** - A Certificate of Insurance naming the Town of Henrietta as an additional insured. Requirements: \$1,000,000 Each Occurrence, \$2,000,000 Aggregate. Successful Bidder must provide Workers' Compensation Form C102.5, which would be obtained from insurance carrier. Proof must be provided showing Disability Insurance Coverage.

7.) All Bids shall be binding for a period of sixty (60) days after the bid opening date. The Town of Henrietta reserves the right to reject any and all Bids and to waive any informalities therein.

Intention: The Town of Henrietta is requesting Bids for cul-de-sac and pump station mowing, in the Town of Henrietta according to the Bid specifications.
