THE TOWN OF HENRIETTA REQUIRES BIDS FOR THE NEW HENRIETTA PUBLIC LIBRARY CONTRACTS: C-GENERAL TRADES, D-PLUMBING AND FIRE PROTECTION, E-HVAC, AND F-ELECTRICAL.

Sealed bids must be submitted to the Town Clerk of the Town of Henrietta, 475 Calkins Road, Rochester, New York 14623, no later than 2:00 p.m. on Tuesday, March 13, 2018, when they will be publicly opened and read aloud. Sealed bids must include, on the face of the envelope, the name and address of the bidder, project name, bid package, and the words "Sealed Bid".

The project generally consists of a New Library Building. The Contract C - General Trades bid includes all General Construction activities. The Contract D - Plumbing & Fire Protection bid includes all Plumbing & Fire Protection activities. The Contract E - HVAC bid includes all HVAC activities. The Contract F - Electrical bid includes all Electrical activities. Every mechanic, laborer and worker shall be paid not less than the prevailing rate of wages as provided for by Section 220 of the Labor Law of the State of New York (PRC# 2017012410). Contractors must be bonded and insured to the level indicated in the Contract Documents. The owner is sales tax exempt and the bidders shall not include sales taxes in their bid.

Beginning February 23, 2018 at 12:00 p.m., the Contract Documents, consisting of the Advertisement, General Contract Bid, Outline Specifications, and Contract Drawings, may be obtained from Passero Associates at www.passero.com under the 'Bid' tab for a fee of \$25.00 (Non-refundable).
