WHEREAS, the Town of Henrietta intends to implement updates to its Comprehensive Plan including reviewing and promoting smart growth for industrial development in the Town while preserving prime agricultural lands in the southwest quadrant of the Town, and

WHEREAS, consistent with the Comprehensive Plan, the Town is considering rezoning portions of the southwest quadrant of Town to industrial, all as more specifically described in the February 15, 2016 letter of intent and associated EAF Part 1 (the "Project"), and

WHEREAS, in carrying out the Action, the Henrietta Town Board is desirous of completing a full SEQR review, including preparing and considering a Generic Environmental Impact Statement in order to fully consider any potential impacts the Action may have, and

WHEREAS, in accordance with the SEQR regulations, the Henrietta Town Board has assumed Lead Agency status with respect to the Action, and

WHEREAS, pursuant to SEQR, the Town Board adopted a positive declaration with regard to the Project on March 2, 2016, and

WHEREAS, pursuant to SEQR, a draft generic environmental impact statement dated March 2016 (the "DGEIS") has been prepared and submitted to the Town Board in relation to the Project, and

WHEREAS, the Town Board has undertaken a thorough review of the DGEIS.

THEREFORE, BE IT RESOLVED, that the Town Board hereby determines that the proposed March 2016 DGEIS is adequate for public review and directs that a notice of completion of the DGEIS be prepared, filed and published on its behalf as required in 6 NYCRR Part 617 State Environmental Quality Review.

BE IT FURTHER RESOLVED, that the Henrietta Town Board hereby establishes a public comment period beginning on Thursday, March 17, 2016, and ending on April 18, 2016.

BE IT FURTHER RESOLVED, that a public hearing be duly noticed and held on April 6, 2016.

BE IT FURTHER RESOLVED, that the attached draft generic environmental impact will be available for public review in the Henrietta Town Clerk's Office, and copies may be obtained through the Henrietta Town Clerk's Office.
