I hereby agree to defend and indemnify the Town of Henrietta and its agents, servants and employees from all claims and lawsuits that may be brought against the Town of Henrietta and/or its agents, servants and employees as a result of my acts or omissions and/or the actions of my dog(s) in the Dog Park.

I hereby release the Town of Henrietta and its agents, servants and employees from all injuries that I and/or my dog(s) sustain in the Dog Park as a result of the acts or omissions of their dog owners/handlers and/or the actions of their dog(s) in the Dog Park.
